TERMS AND CONDITIONS

To make your time with WHO DAT PARTY BUS an enjoyable one, we ask for your cooperation with the following:

WHO DAT PARTY BUS will strictly enforce State and Federal Laws and will maintain a zero tolerance compliance policy that no alcoholic beverages can be consumed or use by any person not of legal drinking age. All U. S. law enforcement agencies have absolute power to stop any motor vehicle for administrative searches. If contraband is aboard, even in negligible quantities without the chauffeurs knowledge, they can seize and forfeit this vehicle to a local government agency. All law enforcement agencies are expressively enforcing this policy. Therefore no person will bring contraband aboard vehicles that are owned and operated by WHO DAT PARTY BUS. WHO DAT PARTY BUS will not be responsible for injuries that may occur due to horse playing while the vehicle is in motion, at a standstill or entering and exiting vehicle. The purchaser on the front of this contract is responsible for his or her guests.

AT THE CAUFFER'S DISCRETION, THE PURCHASER AGREES TO BE FULLY LIABLE FOR ALL CHARGES THAT MAY INCUR:

- (1) \$ 25.00 per broken glassware, \$45.00 per damaged or lost CD/ DVD
- (2) \$150.00 per minimum for extensive cleanup (spills, etc.)
- (3) \$200.00 detailing and wax (due to sickness-exterior)
- (4) \$200.00 shampoo and disinfecting (due to sickness interior)
- (5) \$225.00 minimum for each burn hole, rip or tear to upholstery
- (6) \$175.00 minimum for each act of vandalism
- (7) Triple charge of above listed amounts for all removed / stolen items from vehicle
- (8) Downtime subject to loss of revenue, per each hour lost as stated in contract

WHO DAT PARTY BUS recommends that all and any personal valuables be removed from the vehicle when unattended. We will not be held responsible for any lost, stolen or damage articles. WHO DAT PARTY BUS reserves the right to terminate this or any other contract for noncompliance of the above request, especially if renters do not follow chauffeurs requests in order to obey the rules in this contract. No smoking is allowed in our vehicles. ALL deposits (cash or credit card authorization) are NON-REFUNDABLE. The renter authorizes the immediate 50% deposit & the balance is due immediately upon pickup. All tolls and parking fees are additional. The authorized card holder for the given credit card is responsible for the payment of the total amount, per cash, credit card or money order. NO personal or business checks will be accepted unless prior approval is given by WHO DAT PARTY BUS. As with all contracts, all of the given information from the renter is binding and cannot be changed without WHO DAT PARTY BUS acceptance. If the contract is cancelled after it is signed, WHO DAT PARTY BUS is still authorized to collect the remaining balance in full, if the bus was not re-rented again on the cancel date for the same or higher amount. We will reserve the said date upon the approval of the purchasers credit card as per telephone conversation. The credit card holder gives authorization to use the credit card information over the phone / fax / internet in combination with signed contract. At the time of pick up we need the credit card and valid state photo identification of the purchaser that authorized the transaction of the signed contract. If the purchaser cannot provide all of the above items at the time of the pickup, WHO DAT PARTY BUS will not start the job, as we have no proof of the legal possession of the credit card. Therefore, the risk of not getting paid will give us the right to cancel. The purchaser is still fully responsible to pay the total amount if he/she fails to provide all the above requirements.

WHO DAT PARTY BUS cannot guarantee the availability of overtime. Transfer jobs are priced for immediate pickup/drop-off, no wait time is included, no usage of bar or drinks/food etc. Base price is simple transportation. The overtime for transfers will be billed by ¼ of hourly rate or ¼ of transfer charge. If the customer fails to show at designated pick up location and does not inform office and/or driver, the full amount of the contracted time will be charged. The purchaser authorizes WHO DAT PARTY BUS to charge any additional charges, after they have rendered services, to the purchasers credit card as a supplemental charge. A 20% gratuity will be added to your total charge. If cash payment is selected, the payment is due at the time of the beginning of the rental time. Customer agrees to have WHO DAT PARTY BUS get the authorization for the above credit card and the amount for the event stated above. WHO DAT PARTY BUS shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situations beyond our control. If the party bus rental is to be for a minor under the age of (18) eighteen this agreement must be signed by either a parent or legal guardian over the age of (18).

I the credit card holder / purchaser agree to pay WHO DAT PARTY BUS upon signing this contract. I am satisfied with the terms and conditions above and fully understand and agree. Since WHO DAT PARTY BUS offers high-tech-equipped vehicles, sometimes heat and excessive use of all power-operated equipment may subject the equipment to temporary failure. This will NOT, of course, interfere with the safety of the vehicle itself and therefore will have no effect on continuing or paying of the full contracted trip. WHO DAT PARTY BUS guarantees, that all our vehicles are constantly checked to keep the highest possible standards and eliminate such failures as much as possible.
